INTERNAL REGULATIONS

Art. 1 Categories of Members

There are three categories of Member:

- Founder (participated in the establishment of the Association): pays the annual membership fee required for individual members. Founder members automatically become members of the Technical-Scientific Committee;
- Individual: who contributes to the payment of the annual membership fee required for individual persons;
- Collective: who contributes to the payment of the annual membership fee required for public or private entities, as well as for legal persons. The collective member must nominate and expressly delegate its own representative;

The qualification of “Benemerito” is attributed to all individual or collective members who pay an increased annual membership fee equal to at least five times the quota due to them.

All members are expressly required to contribute in an active and concrete manner to the pursuit of the purposes referred to in Art. 2 of the Statute

Art. 2 Application for registration of the new member

The aspiring member is required to fill out the application form for registration in Annex 1 to these Regulations, accepting the content of the Statute and the Internal Regulations and paying the annual membership fee; he/she will also authorize the processing of personal data.

The member can request the change of data through written communication.

The Secretary will update the Register of Members. The personal data of the members are to be considered confidential and will be managed exclusively by the Board of Directors, in compliance with the Privacy legislation.

The Board of Directors, within a maximum of 30 days from the date of receipt of the request, decides on the admissibility of the aspiring members. In the event of a positive outcome of the admissibility procedure, the Board of Directors will notify the aspiring member, via email, by sending the documentation verifying the data provided, formal acceptance of the statute, the internal regulation and the privacy policy.

The qualification of member is effectively acquired only when the aforementioned documentation is returned signed and the annual membership fee is paid in the manner defined by the Members' Assembly. This will be followed by immediate inclusion in the Members' Register and the issuing of the membership card.

Membership is valid for one calendar year, expiring on December 31st of each year.

Art. 3

Registration requirements for individual members

Each member must contribute with their own skills, possibilities and knowledge to the pursuit of the statutory purposes and provide active and concrete support to the activities of the Association.

For this reason, it is desirable for members to have skills in the macro-areas:

- Cable transport
- Industrial archaeology
- History and culture of the Alpine territory

The Board of Directors, with the possible support of the Technical-Scientific Committee, expresses itself by voting on the admissibility of the candidacy and therefore on whether or not to accept the request.

This procedure must be concluded, with a motivated positive or negative response to the candidate, no later than 30 days after receiving the application for membership.

In the event of rejection of the application, the candidate may reapply, starting from the following year of operation of the Association, when he or she believes he or she is able to satisfy the requirements, also on the basis of the reasons for refusal expressed by the Board of Directors.

Art. 4

Registration requirements for collective members

Public or private entities or legal persons whose activity is relevant to the aims and purposes of the association, as specified in Art. 2 of the Statute, are eligible for the qualification of collective members. The procedure for accepting the application for membership is similar to that described in the previous Art. 3 for individual members.

Each Collective Member has the right to be represented at the Members' Meeting by their own delegate, whose details must be communicated in writing to the Board of Directors following acceptance of the application for membership. The Collective Member will annually renew or confirm their representative, with written communication on the occasion of the renewal of the membership fee.

Art. 5

Membership fees

The basic annual membership fee for the following calendar year is decided by the Members' Meeting.

Collective Members pay an increased annual membership fee, equal to five times the basic fee.

The payment of the annual renewal membership fee must be made by bank transfer or payment into the Current Account in the name of the Association by March 31 of each year.

Art. 6

Technical-Scientific Committee

The Technical-Scientific Committee is composed and structured as described in Art. 11 of the Statute and provides for the rightful participation of the Founding Members, as described in Art. 1 of these Regulations.

The meetings of the Technical-Scientific Committee are governed by the President and are aimed both at analyzing the proposals for technical-scientific activities received by the Board of Directors,

and at formulating new proposals pertaining to the statutory purposes, and at examining the applications for membership that the Board of Directors deems to submit to its attention.

Art. 7

Technical documentation

Historical technical documentation refers to that relating to the projects, construction and instructions for the use and maintenance of cableway systems, technologically outdated and no longer current, which mainly falls into the following types:

- drawings on tracing paper or on paper
- publications with text and illustrations
- photographs and postcards
- films

Art. 8

Technical material

Technical material refers to:

- material forming part of cableway systems no longer in operation,
- decommissioned equipment attributable to the operation or maintenance of cableway systems

Art. 9

Ownership and possession of material

The owner is understood to be the person (or company) who created the original material. The possessor is understood to be the person who at a later stage came into possession of the original or a copy.

The original material may be stored at the owner Company or be scattered across various locations such as:

- Company that produced it or purchased the trademark
- Public or private entities that received it as a donation
- Private citizens who came into possession of it in various ways

Art. 10

Public domain material – Expired copyright

Use license for photographs taken in Italy (or in Italian territory)

According to Law 22 April 1941 n. 633 on the Protection of copyright and other rights connected to its exercise, amended by Law 22 May 2004 n. 128, generic photographs without artistic character and reproductions of works of figurative art become public domain starting from the beginning of the calendar year following the twentieth year from the date of production (article 92). According to the text of the law, such "simple photographs" are defined as "images of people or aspects, elements or facts of natural and social life, obtained by the photographic process or by a similar process, including reproductions of works of figurative art and frames of cinematographic films". Photographs of writings, documents, business papers, material objects, technical drawings and similar products are not included (article 87). Photographs considered works of art, however, become public domain 70 years after the death of the author, in accordance with article 2 point 7 and article 32-bis.
